NAARVA wishes to inform you that its 8<sup>th</sup> Central Region Rally will be held at the Elkhart County 4-H Fairgrounds in Goshen, Indiana from May 30 thru June 6, 2010.

We expect to have over 150 recreational vehicles to register for the Central Region Rally. This is an excellent opportunity for you to present and sell your product(s) to our membership.

We are now accepting applications from vendors interested in selling at this event; i.e. RV related items/services, name tags, scooters, fiber art, clothing, creative crafts and unique items.
